CD-ROM problems

Q: My computer is freezing when I'm using the CD-ROM. What's wrong?

A: Eject the CD from the drive. If you need to, go ahead and restart and eject the disk while the computer is rebooting. Once you've restarted, try putting an audio CD in the drive.

With an audio CD, you can test to determine whether the CR-ROM drive is physically operating.

If the audio CD plays without freezing the computer, your troublesome CD may just need some cleaning.

You can buy a CD-ROM cleaning kit. Or, using a mild dish soap, water, a soft cloth and a gentle touch will do. Remember to clean from the center of the CD disk out.

If your computer is still freezing, it is possible that there is a software conflict and you should seek the help of a technician.

Duplication versus Replication for CD and DVD: What's the Difference?

Understanding the differences is important in determining which process is best for your project. A duplicated CD/DVD is not only created using a different process than a replicated CD/DVD, but the actual final product is also different.

There are two ways to make a copy of a CD or DVD.

- 1. Information can be burned on to a blank CD/DVD-R; this method is called <u>duplication</u>.
- 2. Information can also be added during the CD/DVD manufacturing process; this method is referred to as replication.

Understanding the differences is important in determining which process is best for your project. A duplicated CD/DVD is not only created using a different process than a replicated CD/DVD, but the actual final product is

also different. After the duplication process is complete, the final product is a CD-R or a DVD-R. Replication stampers for CDs produce CD-ROMs. (ROM means Read Only Memory). The final product in the DVD replication process is a DVD-5, DVD-9, DVD-10, or DVD-18.

The Processes

CD duplication is similar to burning a CD/DVD on your personal computer. A CD/DVD duplicator extracts data from the master disc and writes it to a blank disc. The difference between burning multiple CD/DVD-Rs at a duplication facility and burning one on your computer desktop is that the duplication facility burns hundreds at a time on towers that are linked together. Each tower contains several CD/DVD trays so that many copies can be created simultaneously. After all the data has been written unto the blank CD/DVD-R, the information is verified with the master, and the process is complete.

CD/DVD replicates, on the other hand, are created during the manufacturing process. In other words, media like a CD/DVD-R does not exist before the process starts. Before the replication process gets underway, the client master is painstakingly evaluated for data corruption. Then, a glass master containing relevant data from client supplied master is created. Replication begins when a flawless glass master is assured. The glass master is used to develop a stamper. The stamper, in turn, is loaded into an Injection Molding machine that creates CD/DVD replicates. The quality of CD replication hinges upon the quality of the glass master's data. Through each successive step, quality and accuracy is consistently monitored to insure each disc is an exact replica or clone of the original. A layer of micro-thin aluminum is applied to the polycarbonate disc. It is then lacquered for additional protection and printed before packaging.

The client supplied master for CD-R and DVD-R duplication is the same, a CD/DVD-R. CD-ROM replication also requires a CD-R master. While a DVD-R is acceptable for DVD replication, most facilities prefer to work from a client supplied DLT or Digital Linear Tape.

Advantages of CD/DVD Duplication

1. The standard turn-time is 2-3 business days, even for runs up to

5,000 units.

2. Digital full color printing is available with no prepress charges.

Disadvantages of CD/DVD Duplication

- 1. The cost per unit for duplication is higher than replication.
- DVDs can have up to 2 layers of information on each side of the media. DVD-R duplicates can have 1 layer of information on the entire DVD.
- 3. Most duplication facilities are small and are commonly limited to hand assembly of the media into packaging as a result of their low volume runs

Advantages of CD/DVD Replication

- 1. The unit costs are lower than duplicated discs.
- 2. Both offset printing and screen printing is available for replicated discs.
- 3. Replicated DVDs can contain 1 layer (DVD-5) of information, 2 layers on one side (DVD-9), 1 layer on each side (DVD-10) or 2 layers on each side (DVD-18). Many replication facilities are not yet set up for DVD-18 replication.
- 4. Most replication facilities, as a result of their high volume run capability, can auto assemble discs into jewel cases, paper/tyvek sleeves, amaray cases, or cardboard sleeves.

Disadvantages of CD/DVD Replication

- 1. The standard turn-time is 7-10 business days, longer for runs exceeding 100,000 units. Standard duplication turn times are 2-3 business days.
- 2. Most facilities have a minimum order requirement of 1,000 units.

Are There Noticeable Differences?

Both CD duplication and CD replication extract data from the original in the same way. In terms of manufacturing, however, this is where the similarities end. The finished product of either process performs in the same manner, although there will be difference to the eye depending upon the whether the discs are digitally, screened, or offset printed.

CD Auto Run

AutoRun plays CDs as soon as you put them in the drive. If you don't like this feature, you can turn it off. Doubleclick MY COMPUTER. Find your CD-ROM drive on the list, then rightclick on it. Select Properties.

Click the Settings tab and deselect Auto Insert Notification or click the Properties tab and place a check in the Auto Play box. Click Apply and Ok.

IF your CD-Rom doesn't have a button to open and close it, try this: Doubleclick MY COMPUTER, rightclick the CD-ROM drive and select EJECT.

The U.S. Supreme Court has agreed to hear a case challenging school prayer at town meetings, very similar to the challenge here in Lady Lake Florida two years ago. At that time, I along with many others appeared to speak against that challenge brought by Bill Calhoun, an avowed atheist who died last year. We won.

This present case also challenges the practice of a small town in upstate NY that begin town meetings with a prayer -- a practice that the Supreme Court explicitly endorsed thirty years ago in the case of *Marsh v Chambers*. Two women in the NY town-- one Jewish and the other an atheist are trying to say that the practice there discriminates against non-Christians because Christians are generally the ones who volunteer to lead the prayers. The town contends that the volunteer "chaplain of the month" can be either a Christian or a non-Christian.

Some law professors are predicting that the case will become one of the biggest religious freedom cases ever and will redefine the role of religion in the public square. They predict that prayer before school board meetings, high school athletic events, local charity events and many more could be threatened. But some even think that the case will have even broader implications, potentially even bringing an end to prayers at presidential inaugurations, the "In God We Trust" motto on the nation's currency and even the cry "God save the United States and this Honorable Court" at the openings of the Supreme Court's own public sessions. While I'd bet that all these predictions are wrong and that the case will be decided -- one way or another -- on very, very narrow grounds, it's always risky to predict what the Court will do now that it has decided to hear this case.

The challenge to this town's policy seems to be arguing that the Constitution is violated whenever any government body recognizes any religious practice that offends anybody. But that

argument flies in the face of all kinds of American traditions that have consistently been upheld when challenged in Court.

As I've said, I'm hopeful that the Court is ready to overturn more than two centuries of American tradition and constitutional precedents, but I do admit that it's troubling that the Supreme Court has even agreed to hear this case! After all, the Supreme Court had already resolved this very same issue, in favor of prayer, so clearly in the *Marsh v Chambers* case. Let's be watchful and pray and be wary, as the saying goes, of "the camel's nose getting in under the tent."

Company Fare - Hasselback Garlic Potatoes w/ Bacon & Cheese Recipe

! For many people, Hasselback style potatoes are nothing new. Make some slices in a potato, bake, and ...it magically fans out into an impressive looking potato with LOTS of character indeed, making for a brilliant addition to any meal! Ingredients 16 ounces potatoes 3 to 5 garlic cloves, thinly sliced 4 tablespoons butter, melted 2 tablespoons olive oil salt and fresh black pepper Fresh chives (diced) Bacon (cut into large chunks) Shredded Cheese of your choice- 1-cup Sour Cream, recipe follows**

Directions Preheat oven to 400 degrees F. Using a wooden spoon as a cradle, place each potato in the spoon and make several parallel slits into each potato top making sure not to slice completely through. Place 3 garlic slices between slits at the crown of each potato. Toss in a medium bowl with butter and olive oil.

Place on a baking sheet lined with tin foil and sprinkle generously with salt and pepper. When the potatoes begin to "fan out" it's time to make the magic happen. Carefully slip a hunk of bacon into each slit of the potato like so and continue to cook Once the potatoes and bacon are fully cooked (use a knife poke test), coat the potatoes with heaping helping of shredded cheese.

Bake until tops are crispy and potatoes are cooked through, about 1 hour. Transfer to a platter and top with Herbed Sour Cream and chives. Herbed Sour Cream: 1/2 cup sour cream 1/2 teaspoon garlic powder 1 tablespoon finely chopped fresh parsley leaves Kosher salt and freshly ground black pepper Combine ingredients in a small bowl. Season, to taste, and refrigerate until use.
